

GEOMAST PRIVACY POLICY

Our Commitment to our clients

Thank you for showing interest in Geomast Antifire Co. Limited. In order for us to provide you with our service we are required to collect and process certain personal data about you and your activity.

By entrusting us with your information, we would like to assure you of our commitment to keep such information private. We have taken measurable steps to protect the confidentiality, security and integrity of this Information. We encourage you to review the following information carefully.

Grounds for data collection

Processing of your personal information is necessary for the performance of our contractual obligations towards you and providing you with our services, to protect our legitimate interests and for compliance with legal obligations to which we are subject.

When you use our services, you consent to the collection, storage, use, disclosure and other uses of your Personal Information as described in this Privacy Policy.

How do we receive information about You

We receive your Personal Information when you enter a contact with us or use our services and you voluntarily provide us your personal details in order for us to provide you with our services (i.e your name, address, telephone number etc);

Categories of the collected information

In order to enter a contract with us, and in order to provide you with our services we need you to collect the following information:

- Personal Information

We collect the following Personal Information about you:

- Registration information / contractual information – your name, email address, phone number, country of residency, address
- Voluntary information– when you communicate with us (for example when you send us an email) we collect the personal information you provided us with.

- Non-Personal Information

We do not record and collect data from or about your device (for example your computer or your mobile device) when you visit our site. Therefore we do not collect cookie identifiers, and other identifiers such your operating system version, browser type, language preferences, time zone etc.

If we combine Personal Information with non-Personal Information about you, the combined information will be treated as Personal Information for as long as it remains combined.

Tracking Technologies

Cookies automatically collect information about you, your device and your online behavior, in order to enhance your navigation in our services, improve a site's performance, and customize your experience on it.

However, when you visit or access our services **we do not use cookies.**

How we use the information we collect

- Provision of service- we will use your Personal Information you provide us for the provision and improvement of our services to you.
- Protecting our interests - we use your Personal Information when we believe it's necessary in order to investigate and defend ourselves against any third party claims or allegations, protect the security or integrity of our services and protect the rights and property of Geomast Antifire Co. Limited, its users and/or partners.
- Enforcing of policies - we use your Personal Information in order to enforce our policies, including but limited to our Terms, or Client Agreement.
- Compliance with legal and regulatory requirements - we also use your Personal Information as required by law, regulation or other governmental authority.

With whom do we share your personal information

- Legal and regulatory entities - we may disclose any information in case we believe, in good faith, that such disclosure is necessary in order to enforce our Terms or Client Agreement, investigate and defend ourselves against any third party claims or allegations, protect the rights and property of Geomast Antifire Co. Limited, its users and/or partners. We may also disclose your personal information to any regulatory authority having control or jurisdiction over us, you or our associates.

How we protect your information

We have implemented administrative and physical safeguards to help prevent unauthorized access, use, or disclosure of your personal information. Your information is stored on secure servers and isn't publicly available. We limit access of your information only to those employees or partners that need to know the information in order to enable the carrying out of the agreement between us.

Retention

We will retain your personal information for as long as necessary to provide our services, and as necessary to comply with our legal obligations, resolve disputes, and enforce our policies. Retention periods will be determined taking into account the type of information that is collected and the purpose for which it is collected, bearing in mind the requirements applicable to the situation and the need to destroy outdated, unused information at the earliest reasonable time. Under applicable regulations, we will keep records containing client personal data, trading information, account opening documents, communications and anything else as required by applicable laws and regulations.

Your Rights

You may request to:

- a. Receive confirmation as to whether or not personal information concerning you is being processed ,and access your stored personal information
- b. Receive a copy of your personal information
- c. Request rectification of your personal information
- d. Request erasure of your personal information.
- e. Object to the processing of personal information by us.
- f. Request to restrict processing of your personal information by us.



- g. Lodge a complaint with a supervisory authority.

However, please note that these rights are not absolute, and may be subject to our own legitimate interests and regulatory requirements.
